BID TITLE & REFERENCE: Bread, Fresh for Direct Delivery to School Cafeterias, RFP #120403

DESCRIPTION OF PURCHASE:

A pricing agreement, done in conjunction with Santa Rosa and Okaloosa County School Districts, for the supply and delivery of fresh bread products to school cafeterias for use in the preparation of breakfast and lunch meals. Products are delivered fresh on a continuous and frequent basis to cafeterias and distribution sites in all three counties; this bid is awarded to one (1) vendor and not split by low price per item. The Evaluation Committee assessed points for each vendor based on vendor's overall proposal. Agreement awarded to vendor with highest overall points. Contract will initially be awarded for a period of ten (10) months with the right to terminate or to renew the contract for four (4) other successive one (1) year periods (July $1 - June 30^{th}$) by mutual written agreement between District and award.
