DESCRIPTION OF PURCHASE:

A bid to purchase band uniforms to outfit the newly formed West Florida High School of Advanced Technology marching band. The bid is for one hundred and forty (140) uniforms consisting of: bibber trousers, marching coats, Aussie hats, and small plumes for the hats, gauntlets, and hangers. The total bid price is \$38,752.14.

As this is a new band, without prior year's activities, permission has been requested to purchase the following items at this time: one hundred and forty (140) marching coats, one hundred and forty (140) pairs of gauntlets; and seventy-five (75) bibber trousers totaling \$30,247.05. Also permission was requested to purchase the remaining items at a later date to allow the newly formed Booster Club time to raise the remaining matching funds to purchase sixty-five (65) bibber trousers and one hundred forty (140) Aussie hats with small plumes for an approximate cost of \$8,705.09. The entire purchase of uniforms will be completed by December 31, 2012.
