PRE-BID CONFERENCE

Bid #120903 Band Uniforms – Washington High School

The Escambia County School District will hold a pre-bid conference to review requirements for the purchase of band uniforms for Washington High School. Other District schools may have uniform requirements shortly and may participate in the pre-bid conference for information gathering/sharing. All schools are located in the Pensacola. Florida area.

PRE-BID CONFERENCE DATE: Wednesday, September 7, 2011

TIME: 9:00 a.m., Central Standard Time

This conference will be used to provide vendors with information on the needs and wishes of the specific band regarding the uniforms, with rough sketches and information on the uniform desired. After the meeting, a Request for Information will be issued to vendors, detailing the desired uniform. To respond, vendors will then submit detailed specifications and a colored drawing of the proposed uniform. These specifications and drawings will then be used to prepare the official bid document. All vendors must provide a waiver indicating that information/drawing is not copyrighted and that the School District has permission to use both the specifications and color drawings in the bid. At this point, the selected drawing and specifications become part of the District bid and any vendor may submit a sample and bid on the uniforms. A formal bid (RFP) will be issued, open to full competitive bidding, using the selected uniform drawing.

This pre-bid conference is "Step I" of the attached time line included in this document.

Final award will be based on the following point system:

Quality of Garment40 points maximumCost of the Garment25 points maximumDelivery Time10 points maximumCompany References5 points maximum

Bonus Points for Vendor that presented selected design 20 points
