DESCRIPTION OF PURCHASE:

Bid award to lowest bidder meeting specifications for one (1) International 4300 diesel delivery truck chassis and two (2) Thermo King T-100-SO refrigeration units for use by the Central Warehouse for food deliveries to school cafeterias. Trade in of a 1988 Ford Waltco F-2 chassis, District vehicle C500771800 has been authorized - \$2,500.00 trade-in value. Freezer body and lift from this vehicle (C500771800) will be installed on the new International 4300 diesel truck.

The trade-in of two (2) Thermo King RD-11 freezer units, currently installed on District Vehicle C500786800 (2003 Ford) and District Vehicle C500786900 (2004 International) is also authorized. These units will be replaced by the new refrigeration units.

Total purchase price of International 4300 diesel truck: \$73,305.00, less trade-in credit (\$2,500.00) = net purchase price - \$70,805.00. Cost to transfer existing lift to new chassis = \$3,950.00.

Total purchase price of two (2) Thermo King T-100-SO refrigeration units including installation: \$42,777.70, less trade-in credit (\$1,000.00) = net purchase price - \$41,777.70.
