DATE: October 3, 2014 BID TITLE & REFERENCE: Band Uniforms – Pine Forest High School, RFP #150305

#### DESCRIPTION OF PURCHASE:

Band uniforms for the Pine Forest High School marching band. The bid is for: seventy five (75) bibber trousers, one hundred and fifty (150) marching coats, seventy five (75) Aussie hats with plumes, one hundred (100) pairs of gauntlets, and one (1) uniform management software program. The total bid price is estimated at \$41,774.25.

Uniform samples were examined by an Evaluation Committee consisting of two Pine Forest High School staff members (the Band Director, and the Assistant Principal), a seamstress, a uniform mom, the band booster club president and two (2) Purchasing Agents who were not voting members of the committee. The vendors/uniforms were rated by Quality (45%), Cost (30%), Delivery Time (15%), and Service (10%). Bid award to the vendor ranked highest by the Evaluation Committee.
