BID TITLE & REFERENCE: Fast Food Partnership, RFP #151003

DESCRIPTION OF PURCHASE:

An agreement to provide school cafeterias with a list of approved fast food vendors offering specific products. This program serves as one of the District's efforts to follow the National School Lunch Program's recommendation to offer more variety and options in ala carte meals in secondary schools. Products were evaluated and deemed acceptable or unacceptable by means of a student taste test. Decisions to utilize this resource rests with Food Services and each school's cafeteria management. No sales are guaranteed to the vendor and cafeterias have the option to discontinue delivery of any product or vendor providing this service to their school, or to stop delivery if 1) the use of this product does not prove beneficial to that particular school's operation, 2) if student interest decreases, or 3) if product quality decreases. Each school has the option to try new products and vendors, providing they are on the approved list, in order to stimulate student interest and provide menu variety. The initial term of this agreement will be December 1, 2014 through July 31, 2015, with four (4) one-year (1) renewal options available upon mutual consent of both parties. Additional products and vendors may be approved during the course of this agreement. If additional products and vendors are approved, an amendment will be taken to the School Board requesting approval to add the new vendors and/or products.
