

QUESTIONS AND ANSWERS

The following questions have been submitted concerning RFP Erate 470 170064224, PRI Circuits. All questions received by the posted deadline of 5:00 PM, CST, Monday, February 20, 2017 are provided verbatim from what was received and have been answered, using **bold** format.

It will be the responsibility of the proposer to determine what, if any, information from the Questions and Answers provided herein will be applicable in the submission of a proposal for either RFP 470. As stated in Section II (Special Terms and Conditions), Letter Q (Miscellaneous), Number 1: "The submission of a proposal will be prima facie evidence that the Responder has full knowledge of the scope, nature, quantity and quality of work to be performed; the detailed requirements of the specifications; and the conditions under which the work is to be performed."

No Amendment to the RFP will be issued and the Opening date remains unchanged.

1) In response to the RFP mentioned above, are you asking for a quote on Long Distance as well or just the PRI's? If you need Long Distance, can we get a total number of minutes?

We are only needing a quote on the PRI's, however please remember, as part of the ineligible costs, we will also need the price of the DID (Direct Inward Dialing) lines.

2) User Information

☎ Do you have a DID/telephone number assigned to each employee or is each employee assigned an extension?

For the McDaniel Bldg and Hall Center, we have 5 PRI's with 1884 DID numbers.

☎ Will you require phones in the classroom?

Not applicable, there are no classrooms with students at either site.

☎ What models are your current phones?

Not applicable, we are not requesting any phones to be provided.
