The following questions have been submitted concerning Bid#211402, Breakfast and Lunch Entrees. Questions #7 and 8 indicated a need to amend the Bid document. Therefore, Addendum No.#1 has been issued. All questions received have been answered and are provided verbatim from what was received:

<u>BIDDER QUESTION #1</u>: Is this Commodity or Commercial bid and what pricing are you wanting for us to put in the column pricing per case column FFS/MOI/COMMERCIAL?

Bid #211402 is a commercial bid.

<u>BIDDER QUESTION #2</u>: Is this a Category bid do you have to be able to bid everything in a certain Category?

No, the District will accept bids on individual items.

BIDDER QUESTION #3: Do you accept Electronic Signature as many are still working remotely?

No, the District will not accept electronic signatures.

<u>BIDDER QUESTION #4</u>: Would you consider an Alternate item if it is a larger pack size say the spec calls for 20-30 lb. case and ours would be 40 lb. case and the spec is 2M/MA, 1G and our is 2M/MA, 0.5G. We do not want to have the expense of sending sample when our item does not meet the spec exactly and you would not award anyway.

The District will accept a different pack size. However, the 0.5G specification will not be approved.

<u>BIDDER QUESTION #5</u>: This is a hardcopy only bid – We have to send back a hardcopy of the bid?

Yes. a signed, hardcopy bid must be returned.
