Pricing Scores were calculated by determining how much greater each Responder's pricing was than the most competitive price proposal, then dividing the total possible points (60) by that factor. For example, if Responder A's price proposal was \$100, and the most competitive price proposal was \$50, then 100/50=2, and 60/2=30. Therefore, Responder A would receive a Pricing Score of 30 points.
