

GEORGE STONE CRIMINAL JUSTICE TRAINING CENTER UNIFORM REQUIREMENTS

- **1.** <u>Uniform of the day</u> (male and female) consisting of:
 - **A. Shirts** Grey Polo Shirt, (Item# AS6020 at Bosso's or GP2250 at Abbott's) w/ George Stone Criminal Justice logo on left breast in blue.
 - **B. Trousers** Black BDU Trouser (Item# PIF52013 at Bosso's or BDU2895 at Abbott's). Trousers will be bloused. The trousers will not have cuffs. Length of the trousers will be the length so that the lower hem will reach the center of the lacings on the boots.
 - **C. Other** A Black nylon belt with a brass buckle and tip cap (military style). Plain white, V-neck T-shirt (bra is required for female trainees); black socks are required to be worn by male and female trainees; plain black, tactical boots (high top non-slip rubber soles and rubber heels). Boots can be 6" black mesh top. Boots must be able to shine.

Training Center hat - plain black baseball style cap with George Stone logo in white. A black windbreaker/jacket may be worn as an outer garment during cold/inclement weather.

- **D**. The uniform is to be worn only to participate in Criminal Justice training programs and should not be worn in public except directly to and from classes.
- **E. Personal appearance** The uniform worn by trainees immediately identifies them as representatives of this Academy. The respect it commands is determined by the pride with which it is worn, and the condition in which it is maintained. When in uniform, trainees are expected to wear that attire with pride and to maintain their uniform accordingly. Any exceptions to this policy must be in accordance with directive of supervisory personnel.
- **F.** Proper agency uniform may be worn in lieu of the GSCJTC uniform.

- 2. Physical Training Uniform The physical training uniform will be a navy blue (polyester/cotton), long sleeved sweat shirt and navy blue sweat pants; dark blue trunks boxer type (biking shorts under trunks); bras (for females); an athletic supporter for supporter (for males); white athletic socks; running shoes are recommended and white tennis or gym shoes are acceptable; white, jersey-type, round neck T-shirt with academy emblem for all trainees and must have last name stenciled in two inch (2") block letters on back. It also must be worn under sweat shirt when the sweat shirt is worn.
- 3. Range Uniform Uniform of the day/blue jeans or navy blue physical training uniform may be worn at range master's discretion, with black baseball cap and black shoes/boots. Shirts must have last name stenciled in two inch (2") block letters on back. Inclement weather must also be available.
- **4.** The George Stone logo may be purchased and placed on the left breast pocket area or left leg of any outer garment mentioned above.
- **5. Academy Dress Standards** Male and Female

A. Hair – Females

- 1. Hair should not touch the collar of the uniform shirt. Long hair in a bun or contained by a hair net will be permitted, no exotic haircuts.
- **2.** Hair may be cut short in such a manner as to allow proper fitting and wearing of head gear and/or protective gas mask.
- **3**. Hair styles should be simple, neat, and easily maintained. Excessive use of hair spray is discouraged.
- **4.** Wigs or other hair pieces may not be worn.
- **5.** Unnatural hair coloring (i.e., bright red, orange, etc.) or obvious streaking, tipping, etc. is prohibited.

B. Hair- Males

Hair on the back of the neck and around the ears should be short, neat and clean and present a tapered appearance. Sideburns must not extend below the middle of the ear. Beards and moustaches are not permitted.

C. Fingernails

- 1. Fingernails must be neatly trimmed even with the tips of the fingers (i.e., when looking at the palms, one should not be able to see any fingernail extending beyond the fingertips).
- 2. Fingernail polish, if worn, must be clear or natural shade of color.

D. Jewelry

- **1.** No jewelry or personal ornaments should be affixed to any part of the uniform or equipment.
- **2.** Cadets may wear no more than two (2) rings and one (1) wristwatch. None of which will be worn during Physical Training, self-defense, Field Exercises, etc.
- **E. Improper Dress** includes anything other than uniform of the day unless approved by the Training Center Director.
