What is a Magnet School accommodation?



A request submitted to the Escambia County School District Transportation Department that allows you to get transportation to and from school from a Center to either West Florida High School or Brown Barge Middle School.

This request does not go to the school. The school ~~has~~ **ZERO** say if your child gets approved, denied, or waitlisted for transportation.

If you have questions about your accommodation contact Transportation, not the school.

All accommodations are based on a first come, first serve base.

New school year request are only accepted on or after February 1st of the previous school year. (I.E. School year ~~20~~**20**1 request begin Feb 1st, 2020)

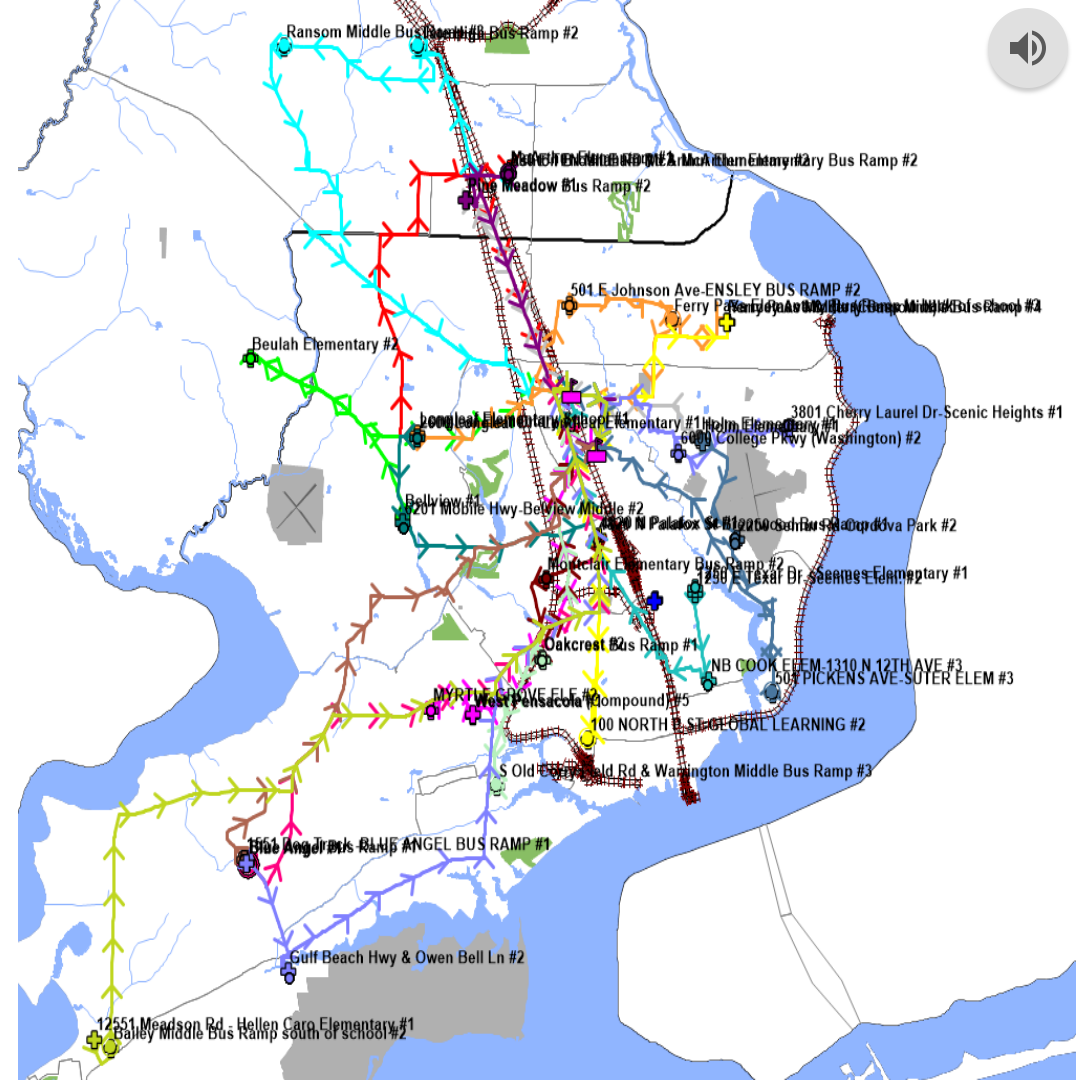
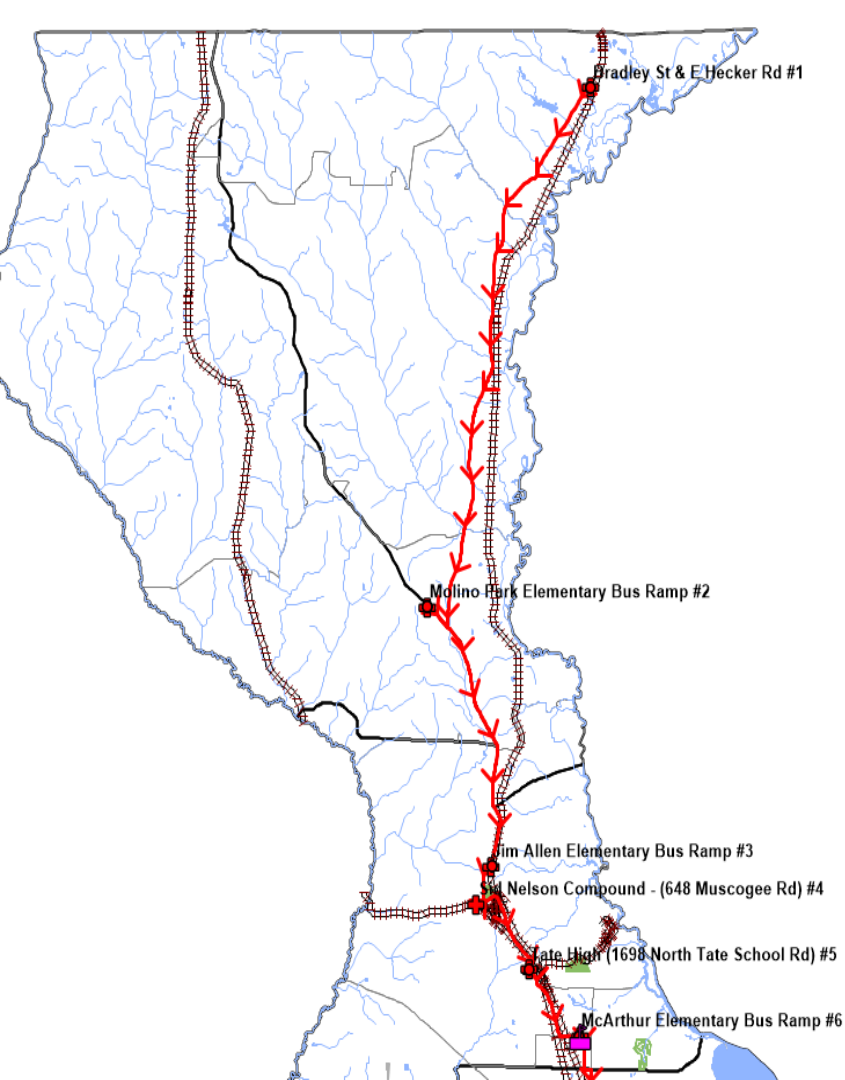


Magnets schools only offer Center 2 Center stops

Some centers will be on the same bus as other centers

Bus do not go to individual houses, daycares, or resource centers

The only exception to this is near the Northern Florida Border at



SCHOOL ENROLLMENT AND AFTER-SCHOOL CARE CHOICES SHOULD NOT BE MADE ON THE PRESUMPTION THAT COURTESY TRANSPORTATION WILL BE PROVIDED. Alternative transportation plans should be made and **ASSUMED NECESSARY** until confirmed otherwise.

All accommodations are granted on a space-available, first-come-first-served basis. Accommodations must be requested along existing bus routes, and new bus stops cannot be created for accommodations. Requests must be resubmitted each year.

Only requests submitted between **February and July 1** of the current year will be considered for approval in time for the start of the next school year.

Additional conditions governing this service are articulated in School Board Rules 6.04(6) and (7).



Filling out the request

Make sure you select either West Florida High School or Brown Barge Middle School for the school of choice.

Use the correct student number and name in the box.

Include three choices for what pick up sites you would like.

Include a good working email for correspondence.



Next Step

Depending on when you submit will determine what happens

You will get one of four emails with one of the following statuses:

Approved Check focus to see what stop you where approved

Waitlisted You are waiting for other students to not ride to get a seat

Pending You filled out your accommodation request wrong and I need more information

Denied Duplicate requests, Parent Cancel, or All centers requested shut down



How Waitlisted Works

Waitlisted students are waiting for a number of seats to open on the requested buses so that they may be sat on the bus.

Students get removed from the bus if they do not ride for two weeks straight (The exception is if it is due to sickness or the parent calls to hold the accommodation due to circumstances).

As soon as a seat is open your child will be placed on a bus and an email will be sent with important bus details. That student is allowed to start riding immediately.

You do not need to contact the school, talk to the bus driver, or do anything other than get your child to the approved Center.



Sibling Preference

Sibling Preference is a system in place that allows students that have siblings on the bus to jump to the front of the line to get onto the bus.

Sibling preference only applies if both students are attending the same school

Sibling preference only applies if both students ride the same bus

Sibling preference only applies if one of the students currently holds a seat on the bus from the prior year
