- a. Investigations Update Mr. Bryant updated the committee on an open investigation involving the booster club for the Ransom Middle School chorus program. The suspect has been arrested and awaiting trial. Mr. Bryant also notified the committee of a current investigation of a Charter School regarding an employee's pay schedule. The investigation is currently in progress. Mr. Bryant stated he is available to discuss further as requested.
- b. FEMA Update Mr. Bryant updated the committee on the status of FEMA projects. There is about \$12-13 M total in damages. Holm Elementary & C.A. Weis Elementary took on most of the damage.
