DATE: June 6, 2016 BID TITLE & REFERENCE: Fresh Produce for Direct Delivery to School Cafeterias (Includes Farm-to-School Program), RFP #162102

DESCRIPTION OF PURCHASE:

An agreement for the establishment of a list of approved fresh produce vendors and to define specific products that may be purchased by cafeteria managers for use in breakfast and lunch meals in school cafeterias. The agreement supports the Farm-to-School Program, a collaborative project of the Department of Agriculture, that connects schools and local farms to promote the use of locally grown healthy foods in the K-12 school setting, improves student nutrition, educates students about food and health, and supports local and regional farmers. Farm-to-School produce may be purchased directly from the vendor(s) on this list or the District/Department of Agriculture may contract directly with a local farmer and use vendor(s) on this list for product pickup and delivery to District cafeterias.

Vendors were rated in four (4) areas, with award to the two (2) vendors earning the highest point value. The decision concerning vendor utilization and school assignment of vendor or vendors will be made by the Food Services Department. The price on the RFP Tabulation reflects the vendor's distribution fee per product and points rating. The cost of the products will be the vendor's actual cost plus the distribution fee.

Effective Dates: July 1, 2016 through June 30, 2017 with four (4) one-year renewal options upon mutual consent.
