## RFP AMENDMENT #1 March 4, 2022

This Amendment shall amend and append the following information to the original RFP document:

- 1) The RFP opening date has been changed to Tuesday, March 22, 2022, 1:30 p.m. CST.
- 2) To amend Section I Introduction & General Information, page 2 and Section V. Proposal Format and Evaluation Criteria, page 16, to include:

If the number of submitted proposals exceeds the scheduling capacity for the Responder presentations on March 29-30, 2022, the District reserves the right to select the top ten (10) ranked Responders using the Evaluation Criteria and Award on pages 18-21 (excluding the Program Cost Proposal – 35 points and Responder's In-Person Live Presentation - 5 points).

If needed, the preliminary review of the submitted proposals will be held on Wednesday, March 23, 2022 at the Spencer Bibbs Center, 2005 North 6<sup>th</sup> Ave., Pensacola, FL 32503 at 8:00 a.m. CST.

The maximum total of sixty (60) points for the preliminary review will be awarded to the Responder with the most responsive and responsible proposal for <u>each</u> school level principal group. The other nine (9) Responders will be awarded less than the total maximum points based on their comparison to the most competitive proposal.

The ten (10) ranked Responders will then be scheduled for the mandatory, in-person presentation and question and answer session with the Evaluation Committee on March 29-30, 2022 for final award consideration. The final score will include the remaining forty (40) points - Program Cost Proposal (35 pts.) and Responder's In-Person Live Presentation (5 pts.).

3) To amend Section VI – Evaluation Criteria and Award, Item #7 – Company Profile, page 20, as follows:	
A copy of a current state issued business license. The State of Florida is preferred.
